**Notice Inviting application for Domain Experts on contact.**

JSCB has started functioning w.e.f. 01<sup>st</sup> September 2012 and invites application from eligible candidates including those who have taken VRS from any bank or retired employees of any Bank to act as Banking expert/consultant (hereinafter consultant) for the following activities:

- Developing Risk Profile Template for risk assessment and management in the bank in day to day banking;
- Investment policy and Treasury Management.
- Asset and Liability Management.
- Any other activity incidental to the above.

**1. Objective and Scope of Work for the consultant:**

- a) Risk Profit Template (RPTs)- Develop RPTs for different type of risks having forward looking elements. The template should be capable of generating and objective measure of 'net risk' for the bank by considering the inherent risk and existing controls for each type of risk. The consultant would have to study the risks under different categories and suggest measures to manage such risks.
- b) Investment & Treasury Management: - Develop strategy and plan for investment for better and high returns.
- c) Asset and Liability Management- Based on the experience and resources work on asset and liabilities management of the JSCB on regular basis.

The consultant would be required to work in close co-ordination with officers of JSCB. Further, the consultant's report/recommendations should be research based and supported by relevant data. The consultant would be required to develop suitable "standard operating Procedures" (SOPs) for different functions viz. Investment & Treasury operation management, ALM and credit operations.

**2. Eligibility Criteria:**

- The applicant should be a professional of high repute.
- The applicant should possess a minimum of 15 years of relevant experience of engagement with bank.
- The applicant should have a proven track record of handling Credits and treasury management of Bank.

### 3. Short-listing of Consultants:

A committee Consisting of senior officer of the JSCB, would examine the documents submitted by the applicants in connection with Expression of Interest. Based on the relative experience, expertise & other parameters mentioned in the eligibility criteria detailed in the EOI Document, the committee will prepare a short list of applicants. Shortlisted candidates shall be called for interview before a panel of experts at a later date.
